LIT Extravaganza Planning from SIT Discussion	 Thoughts on LIT Extravaganza: A quick flash survey question about what teams would like to see at the LIT Extravaganza! Going back to basics about CSPs and Act 264 due to a lot of staff turnover. Discussion of how meeting facilitation impacts effectiveness of the CSP meetings and planning. Training video – VFF overview of CSPs and SIT video of meeting facilitation. Lead off the day with a summary of CSPs and Act 264 to level the playing field for everyone – whether it is one of the videos or a speaker. Working toward consistency across regions. Currently there are many differences across regions depending on size and how long staff have been in their positions. The vision and the hope of the law is (a) coming together in family/student centered collaboration, as well as (b) looking at improving the system of care. All the different roles of various participants tend to lend to one focus or the other. How do we help them balance the two and clarify the two functions?

Discussion around Parent Representative work	 Concern was expressed around Parent Representative role historically being able to be chosen by LIT, and now is being decided, and changed, by an outside (of the LIT) organization. Some LITs have had the same person for many years. Concern expressed about how notification was communicated to those in the role, in the LITs, and in the system of care. Talked about both the personal and technical aspects of this process. We need to be a part of the ongoing process of renewal and keeping the work going. The Board is concerned with making sure the Parent Representative role continues and continues to be funded going forward. So we want to make sure we are helping to spur the grant/role on past the one-year grant term currently awarded. 	
Wrap Up and Next Steps	 Agenda Items to discuss for July meeting: Future recommendation from the Board that: Funding for the Parent Representative role should not be the sole responsibility of the Department of Mental Health. It should be funded jointly by all the entities legally responsible. Continue discussion on Parent Representative, addressing current concerns in the notes above. Laurie Mulhern, Board member, will present on Child Protection Registry work undertaken by DCF over the past year. 15 minutes Ways to increase a consistent, efficient, and accurate method of tracking Coordinated Services Plan data. Development and support of Vermont's Strategic Plan for Suicide Prevention. Support of this plan may be considered as part of our recommendations.
